Vessels can be moved outside for work not allowed inside heated storage buildings prior to launch.						
5.	All boats/PWC's must be out of storage buildings by June 1 <sup>st</sup> . If boat/PWC is not removed by June 1 <sup>st</sup> , owner shall pay a storage fee of \$5.00 per day and will also be held responsible for the cost of moving to another location if necessary.
