1. In considerate of \$ \_\_\_\_\_, payable in **full** at time boat is put in storage. **If not paid in full by December 1<sup>st</sup>, a \$100.00 late fee will be assessed without notice.**
2. **Dubbert's Outdrive Services Inc. will not be responsible or have liability for any loss or damage to above boat (including tools, accessories, or safety equipment), or any personal belongings of owner occasioned by theft, fire, flood, windstorm, cyclone or other cause beyond reasonable control of Dubbert's and owner shall cover said risks by insurance without subrogation against Dubbert's.**
3. Boats/pwc's will not be removed from Dubbert's before all storage, repairs and other charges at Dubbert's are paid in full. Boats can be removed on or about April 1<sup>st</sup>, in approximately the inverse order in which they were stored. Boats may be moved outside after April 1<sup>st</sup> to accommodate launch schedules without notice. Additional shoring fees will apply if vessel is to be move back inside or if owner request that vessel be moved outside for bottom painting or other work not allowed inside building prior to launch.
4. If boat/pwc is not removed by June 1<sup>st</sup>, owner shall pay a storage fee of \$5.00 per day and will also pay the cost of moving to another location if necessary.
5. No person, other than the owner or captain of boat shall enter the yard to work on the boat unless approved by Dubbert's. A scheduled time must be given for an approved outside contractor to work on boat.
6. Owner, his agents, employees, and guest shall comply with all the rules and regulations established by **Dubbert's** and shall not engage in immoral or illegal activities at properly owner by **Dubbert's** which are in violation of any city, state, or federal ordinance.
7. Upon breach of any terms above, **Dubbert's** may cancel and terminate this contract upon 48 hour notice to owner. Such notice may be given personality or by mail. No refund will be mailed upon termination. Upon expiration or termination of this contract for any reason, owner shall remove boat from the premises unless other arrangements have been made with **Dubbert's**.
8. All invoices paid by credit card will be assessed a 2% surcharge. Phone payments are not available for storage fees.
